## The Family of Louis and Lydia (Fosdick) Lambert Ma(s)cillier of Boston, Virginia, and Guadeloupe: The First Known Catholic Mayflower Descendants in Massachusetts

Throughout the colonial period, no official Catholic congregations were allowed in Massachusetts. Local laws forbade any Catholic priest even to enter the colony. The 1780 Massachusetts Constitution established religious freedom in the new state, and the first public Catholic Mass was held in Boston on 2 November 1788 in a small formerly Huguenot meetinghouse on School Street. The Church of the Holy Cross was erected in Boston in 1803. The earliest Catholic records, beginning in 1789, are largely for French and Irish residents, with only the occasional Yankee surname. Within the first sixty-one pages of the first volume of Boston Catholic records are found the 1796 and 1798 baptisms of the two daughters of Louis Lambert Ma(s) cillier, a native of Guadeloupe, and his wife Lydia Fosdick, a William Brewster descendant. These eighteenth-century baptisms are the first and only known Catholic baptisms for *Mayflower* descendants in Massachusetts before 1800.1

Early Catholic records are digitally available on AmericanAncestors. org through a collaboration between the New England Historic Genealogical Society and the Roman Catholic Archdiocese of Boston. The first volume of records for Holy Cross in Boston spans 1789–1810 but includes Catholic sacramental records that occurred elsewhere in New England, including Newburyport and Wrentham, Massachusetts; Portsmouth, New Hampshire; and Newport, Rhode Island.

Lydia Fosdick was born in Connecticut, possibly in her mother's native Norwich, to which she returned later in life. Her parents were in Boston by the birth of her brother in 1781 but also lived in Windham, Connecticut, and Rutland, Massachusetts. Lydia and her husband Louis

Lambert Macillier were married at Boston on 15 July 1794 by Rev. John Lathrop, minister of the Second Church in Boston, then located on Hanover Street. A newspaper account of their marriage refers to Lydia's father as Alvin Fosdick.<sup>2</sup> The baptism of Louis and Lydia's first daughter reads in the original French:<sup>3</sup>

Le Second du mois d'Avril 1796 a été baptize Marie Catherine Elizabeth née le dix neuf du mois de Mars dernier, fille de Mr Louis Lambert et de M de Lydie Fosdick, tous deux habitans de cette Ville. Le Parrain, Mr. Eusébe Lambert, et Mr. Alvan Fosdick, et la Marraine, M de Marie Catherine Riviere Lambert, representeé par M de Rebecca Wright, et M de Lydie Tracy Fosdick, et out signé.

Mary Catherine Elizabeth Lambert died "suddenly" at Boston on 23 September 1797, aged 18 months, and Louis and Lydia's next child was born and baptized a few months later:<sup>4</sup>

Die decimá quintá Mensis Marti 1798 baptista est Emilia Mathilda natá die vigesimá terta mensis Januarie ejusdeux anni, filia Ludovic Lambert Macillier, et Lydieae Fosdick ejus uxoris. PP. Augustine Gallet et Catharine Elizabeth Lambert absens cujus personaus gessit Lydia Tracy Fosdick.

Louis Lambert was a business partner in Boston with his father-in-law Alvan Fosdick as part of the firm Fosdick and Lambert. During the Quasi-War between the United States and France, Fosdick and Lambert's schooner *Three Friends* sailed on a commercial voyage from Boston around 29 June 1798 bound for Guadeloupe. She was captured on or about 25 July 1798 by a French privateer called *Les Amis* and carried to Port Liberty, Guadeloupe. She was "condemned as good prize" by a French Tribunal on 9 August 1798 and ordered to be sold.

As the newly appointed administrator on the estate of Alvan Fosdick, deceased, surviving member of the late firm of Fosdick and Lambert, formerly of Boston, in the State of Massachusetts, Gilbert Clement Huntington (grandson of Lambert and great-grandson of Fosdick) filed a French Spoliation Claim in 1886 before the United States Court of Claims regarding this seized ship. The information within these files, citing an 1808 record on the schooner, largely refer to Louis Lambert

Macillier as "Louis Lambert Mascillier." The court ultimately found in Huntington's favor, awarding him \$13,517 as the administrator of the estate of Alvan Fosdick.<sup>5</sup>

The family of Alvin and Lydia (Tracy) Fosdick were briefly treated in the 1868 *Hyde Genealogy*, a notable exception for carrying female lines well after the Hyde surname. The genealogy notes that Alvin and Lydia had three sons—Phineas, Gregory, and John—and a daughter named Mary or Lydia. Lydia's daughter Amelia married her first cousin once removed, Roger Huntington, also a Hyde descendant, but Amelia's parents are not mentioned in Roger's treatment. Roger Huntington served as a member of the Connecticut House of Representatives, senator, and comptroller of the state of Connecticut.<sup>6</sup>

## **Genealogical Summary**

1. ALVAN FOSDICK<sup>7-7</sup> (Ezekiel Fosdick<sup>6-6</sup>, Samuel Fosdick<sup>5</sup>, Mercy Pickett<sup>4</sup>, Ruth<sup>3</sup> Brewster, Jonathan<sup>2</sup>, William<sup>1</sup>; Susannah Turner<sup>5</sup> [wife of Samuel Fosdick<sup>5</sup>], Ezekiel Turner<sup>4</sup>, Mary<sup>3</sup> Brewster, Jonathan<sup>2</sup>), was born at Wethersfield, Connecticut, 9 March 1750, son of Ezekiel and Abigail (Wright) Fosdick. He died at Hudson, New Hampshire, 7 July 1831, and is buried there at Center Cemetery.<sup>7</sup>

He married say 1772, **LYDIA TRACY**. She was born at Norwich, Connecticut, 26 December 1749, daughter of Elisha and Lucy (Huntington) Tracy. Lydia died 28 November 1825. Lydia's gravestone is at Old Norwichtown Cemetery in Norwich, near her parents.<sup>8</sup>

Alvan Fosdick was involved in several deeds in Norwich. He purchased land from Benjamin Huntington on 14 April 1777, when

both were listed as residents of Norwich. On 23 April 1781, Alvan, then a resident of Windham, Windham County, Connecticut, sold some of this Norwich land purchased in 1777 to Daniel Kelly of Norwich. On 12 December 1785, Alvan, now a resident of Rutland, Worcester County, Massachusetts, sold land in Norwich to Thomas Coverly of Norwich. On 1 September 1786, a judgment was entered in the deeds in favor of Christopher Leffingwell, Esq., of Norwich, against Alvan Fosdick of Rutland for the sum of £9.11.11¾ Lawful money Debt. and associated court costs. On 17 June 1789, Thomas Coverly of Boston, merchant, sold land in Norwich to Alvan Fosdick of Rutland, merchant. On 17 June 1793, Alvan Fosdick of Boston, merchant, sold land in Norwich to Samuel Leffingwell. On 1 August 1808, Alvan Fosdick of Salem, Rockingham County, New Hampshire, merchant, sold some of his Norwich land purchased from Benjamin Huntington to Jabez Huntington of Norwich.

Within land records in Windham, Alvan Fosdick of Norwich purchased land there from Gamaliel Badcock, also of Norwich, on 22 April 1777. On 7 February 1793, Alvan and Lydia Fosdick of Boston, along with many others who were heirs of Benjamin Follett of Windham, deceased, sold land in Windham to Abner Follet of Windham.

Within deeds of Worcester County, Alvan Fosdick of Boston, merchant, purchased land in Rutland from Thomas Coverly (and wife Lucy) of Rutland, trader, on 27 March 1784. Alvan Fosdick (and wife Lydia) of Rutland, merchant, sold some of this land in Rutland to Samuel Barret and William White, both of Boston, merchants, on 27 June 1785. Alvan Fosdick of Rutland, merchant, sold some of this land in Rutland to Benjamin Clark Cutter on 26 June 1786. Alvan Fosdick of Rutland, trader, loaned three pounds, twelve shillings eleven pence on 4 July 1786 to Silas Nye of Barre, Worcester County, gentleman. Nye was sent to jail on 28 February 1787 for nonpayment of the debt, for which Alvan Fosdick was conveyed three and a half acres of Nye's land in Barre. Alvan Fosdick, now of Boston, gentleman, sold this land

in Barre to Isaac Stone of Oakham, Worcester County, esquire, for five pounds, fourteen shillings on 22 December 1789.<sup>22</sup>

Within deeds of Suffolk County, Massachusetts, Alvan Fosdick of Boston purchased a brick tenement in Boston from James Fosdick, Timothy Starr Jr. (and Mary his wife), Sarah Fosdick, and Lucretia Fosdick, all of Middletown, Hartford County, Connecticut, for 218 pounds, fifteen shillings, signed in March 1781 and entered into the record on 17 April 1781. Alvan Fosdick of Boston, merchant, with his wife Lydia, sold this tenement along Milk Street in Boston to Thomas Coverly of Rutland, Worcester County, merchant, for 450 pounds, on 27 March 1784. The 1798 Boston Directory lists "Fosdick Alvan, merchant, house Garden court," and "Fosdick & Lambert, merchants, No. 62, Long wharf." The 1800 Boston Directory lists "Fosdick Alvin, North Square."

Samuel Adams of Westford, Middlesex County, Massachusetts, merchant, sold land in Westford on 30 November 1796 for \$1,000 to three parties in proportionate amounts: Wright & Briggs of Boston, merchants (\$207), Fosdick & Lambert of Boston, merchants (\$601.37), and Samuel Tuttle of Littleton, Middlesex County (\$190.63).<sup>27</sup> Alvan Fosdick and Louis Lambert of Boston, merchants, sold their threefifths share of this land on 7 October 1799 to Wright & Briggs of Boston, merchants, for \$300.28 On 29 June 1812, a judgment against Asaph Whitcomb of Stow, Middlesex County, was made in favor of Alvan Fosdick of Boston for \$152.19, resulting in some of Whitcomb's land in Stow being granted to Fosdick to satisfy the judgment.<sup>29</sup> Alvan Fosdick of Salem, New Hampshire, merchant, sold this land in Stow to Nathan Corey of Westminster, Worcester County, on 29 August 1816 for \$160.30 According to the 1883 deposition of Amelia Matilda (Huntington) Thomas, her mother Amelia Lambert boarded with her maternal grandfather Alvan Fosdick in Boston for two years starting in 1816, although no contemporary records have been found showing that Alvan Fosdick still lived in Boston by that year.<sup>31</sup>

No deeds for Alvan Fosdick were found in Rockingham or Hillsborough Counties, New Hampshire. He was recorded in town records of Stow on 2 March 1810 regarding an order in his favor.<sup>32</sup> Alvan was enumerated in the 1810 federal census in Littleton, Massachusetts, with a household consisting of one male over 45, one female 26 through 44, and one female 10 through 15.<sup>33</sup>

The *Hyde Genealogy* says Lydia survived her husband and died in Norwich, although they likely separated for a few decades before their deaths.<sup>34</sup> Lydia's gravestone reads "Lydia Fosdick, wife of Mr. Alvan Fosdick, born Dec. 26, 1749, died Nov. 28, 1825." Alvan's death in 1831 was reported in Boston newspapers as "In Hudson, N.H. 7th inst. Capt. Alvan Fosdick, formerly merchant of this city, aged 81." Before 1830, Hudson was known as Nottingham West, and Alvan was enumerated there in the 1820 and 1830 federal censuses. In 1820, the schedule recorded one male and one female, both over 45. In 1830, the schedule recorded one male between 80 and 89 and one female between 60 and 69. As Lydia had already died, this female is a possible second wife. Alvan's title of "Captain" likely came later in life, as there is no record of his service in the Revolutionary War.

No probate records were filed in Alvan Fosdick's lifetime. His great-grandson Gilbert Clement Huntington (1841–1893) started probate proceedings on 19 July 1886 regarding the estate of his ancestor:

Alvin Fosdick, who last dwelt in Boston in said County of Suffolk died during, or about the year of our Lord eighteen hundred and eighteen, intestate, possessed of goods and estate in the nature of our unliquidated claims remaining to be administered, leaving widow Lydia, three children next hereinafter named as next of kind to said Alvin, and as his only next of kin, the persons whose names, residences, and relationship to the deceased are as follows, viz: — John M. Fosdick, a son since deceased without issue and leaving widow and Lydia Fosdick a daughter since deceased leaving issue and Gregory Fosdick a son since deceased unmarried and without issue and intestate, said claim is one of the 'French Spoliation Claims' so called on account of capture by the French of the Schooner *Three Friends* in 1798.

This "1818" reference to Alvan's residence in Boston appears to be derived from Gilbert's mother Amelia's statement that she resided with her maternal grandfather Alvan Fosdick in Boston for two years starting in 1816.<sup>37</sup>

The payments out of the French Spoliation Claim to the estate of Alvan Fosdick, with distribution to his heirs, did not proceed until 10 May 1900, seven years after Gilbert Clement Huntington's death, with Gardner Greene of Norwich now acting as administrator. The living descendants of Alvan Fosdick were all through his daughter Lydia, with six of the latter's grandchildren. Complicating the distribution was that "Matilda Lambert Delano and Delilah Lambert, children of Gabriel John Lambert, who have not been heard from for forty years, and whose whereabouts is unknown," resulted in the shares listed with two theories of distribution, either in quarters or in sixths.<sup>38</sup>

late of Boston." Amelia Mathilda (Lambert) Huntington (1798–1883), may have been the 10 to 15-year-old female living in Alvan Fosdick's household in Littleton, Mass., in the 1810 census.

Payments were made to all of the above heirs by 15 August 1901, except Matilda and Delilah, entitled to receive \$1,519.06 and \$1,519.05, respectively. Notices were taken out in the *New York Daily Tribune*, *Norwich* [Conn.] *Morning Bulletin*, *The Boston Traveler*, and the *Daily Picayune* [New Orleans], the first three paragraphs for Delilah reading as follows (with a similar notice for Matilda immediately following):

COMMONWEALTH OF MASSACHUSETTS – Suffolk, ss. – Probate Court. – To Delilah Lambert, an absentee, who formerly resided in New York, in the State of New York, having property in said County: to all persons claiming an interest in the property hereinafter named, and to all whom it may concern:

Whereas, a petition has been presented to said Court to appoint Eliza Matilda Huntington, of Philadelphia, in the Count of Philadelphia, and State of Pennsylvania, or some other suitable person, receiver of the following described property of said absentee, to-wit: A certain deposit, with the accumulations thereon, in the United States Trust Co., standing in the name of the Judge of Probate for the County of Suffolk.

You are hereby cited to appear at a Probate Court, to be held at Boston, in said County of Suffolk, on the FOURTEENTH DAY OF

JANUARY, A.D. 1904, at 10 o'clock in the forenoon, to show cause, if any you have, why the same should not be granted.<sup>41</sup>

Neither party appeared at court, and the amounts were ordered to be transferred to Frederick A. P. Fiske as a receiver on 30 January 1904. <sup>42</sup> See the chart of the descendants of Alvan Fosdick noting the heirs that received the money from his estate paid in 1901 (seventy years after Alvan's death in 1831), based on the proceeds of the French Spoliation Claim of Fosdick and Lambert's ship taken in 1798.

## On 7 January 1794,

Louis Lambert, of Grand Terre, in the Island of Guadaloupe [sic] now residing in Boston in the County of Suffolk, Merchant, and by his petition sets forth that he has resided in the Commonwealth of Massachusetts more than two years and prays (he being an Alien) that he may be admitted to become a Citizen of the United States of America according to the direction of the Act of the Congress of the said United States, in such case made and provided. Whereupon the Court upon due enquiry made find that the fact alleged in said petition is true, and that the said Louis Lambert is a person of good character. The said Louis Lambert is thereupon admitted by the Court to become a citizen and the oath prescribed by law to support the Constitution of the United States is administered to him in open Court, and thereupon the said Louis Lambert is and shall be considered as a citizen of the said United States accordingly.<sup>48</sup>

Louis Lambert Macillier of Boston, merchant, purchased a dwelling house and land along Marlborough Street from James Cutler of Boston, merchant, for \$5,000 on 11 September 1795.<sup>49</sup> This land, with Lydia signing as Louis's wife, was purchased with a mortgage of \$3,125, which was acknowledged by Cutler as being satisfied on 24 March 1797.<sup>50</sup> Louis sold this land on 5 February 1796 to Paul Joseph Gerard de Nancrede of Boston, gentleman, for \$5,135, with instructions for the grantee to pay \$1,000 with interest within one year to satisfy the mortgage between Louis and James Cutler.<sup>51</sup> This sale also had a mortgage deed between Louis and de Nancrede (which he signed with his wife Hannah) for \$4,135, which was also noted as satisfied on 24 March 1797.<sup>52</sup>

Louis Lambert appears in the following Boston directories:<sup>53</sup>

1796: Lambert Lewis, merchant, house Fleet street.

1798: Lambert, Louis, Fleet street.

1800: Lambert Macillier, Louis, house Fleet street.

Louis Lambert does not appear in the next available city directory of Boston in 1803, by which time the family had moved to Alexandria, Virginia, when "Louis Lambert & Co.," had advertisements in Alexandria newspapers. <sup>54</sup> On 21 September 1802, the *NewYork Gazette and General Advertiser* noted the following arrival at the port of New York: <sup>55</sup>

Same day, at quarantine, the schooner Hector, Chamming, in 17 days from Guadaloupe, with sugar, to Brune & Erich, H. Cruger, and Louis Lambert, passenger. The blacks very troublesome at Guadaloupe. *Spoke*, lat. 30, long. 70, brig Mary, 5 days from New-York for Martinique. Same latitude, brig Friendship, 24 days from Portsmouth for Demerara.

Louis Lambert's death was reported in newspapers in Boston and Alexandria. The *Alexandria Daily Advertiser* reads:<sup>56</sup>

Died in Guadaloupe, about the 28th of September last of a consumption, Mr. Louis Lambert, of the House of Louis Lambert & Co. late of this place. He has left an amiable widow and three small children, to bemoan the loss of an affectionate husband and [illegible].

Within the French Spoliation Claim of Gilbert Clement Huntington is a deposition of Amelia M. H. Thomas, a witness called on behalf of the claimant, taken before Charles F.Thayer, a notary public, at Norwich, Connecticut, on 6 March 1888. The deposition noted Amelia, aged 50 and a resident of Norwich, was the "grand-daughter of the late Lewis or Louis Lambert Mascillier, and the great grand-daughter of the late Alvan Fosdick of Boston." Regarding her mother's early years, Amelia Thomas notes:

My mother Amelia Matilda Huntington (born Lambert) related to me on the night of 14-15, May 1883, a partial history of her life from my interrogatories, which statement I wrote down as she dictated to me and went over the same statements several times while writing down her words. In this statement made to me during the night of 14-15 May, she said that at the age of seven years and seven months, namely in August, 1805, her father placed her in a convent in Baltimore, her parents being on the eve of sailing for Guadaloupe, West Indies, and that her father the aforementioned Louis Lambert, died in September, 1805, two weeks after they landed in Guadaloupe. My mother furthermore stated to me, which I carefully wrote down, that in the year 1816 she went to Boston and boarded with her grandfather Fosdick, the aforesaid Alvan Fosdick, two years. On the following morning, the 15th of May, 1883, I showed this narrative of my mother's early life to my brother, Louis Charles Lambert Huntington, who died in November 1887, in St. Martin, West Indies. He, my brother, then made several copies of this same narrative questioning my mother in reference to each of her life, and she repeated to him the same facts.<sup>57</sup>

A gravestone for Lydia and Louis at Yantic Cemetery in Norwich reads:<sup>58</sup>

In Memory of Mr. Louis Lambert. Who died at Guadaloupe. 25 September 1805. Aged 49 years. And Mrs. Lydia Lambert Who died at Norwich 21 July 1848, Aged 74 years.

in Company B of Georgia's 10th Infantry, and was promoted to Assistant Surgeon of the 53rd Georgia Infantry Regiment on 28 July 1863. He was hospitalized 15 Sept. 1864, and furloughed Feb. 1865, and reported absent on 31 March 1865 after having applied for retirement at Augusta. Amelia's will, dated 13 Sept. 1898, with a codicil dated 2 Nov. 1898, named the following relatives: "Eliza Matilda Huntington and Caroline Maria Huntington, daughters of my deceased brother Louis Charles Lambert Huntington;" halfsister Mary Ann Huntington; nephews Louis Charles Lambert Huntington and James Clement Huntington of Philadelphia, and James's son William Swope Huntington; niece Lillie Isabel Midlen, and her daughter Lillie Huntington Midlen. Items of particular interest mentioned in the will included "one large French silver serving spoon marked 'L.M.,' which spoon I wish should always be kept in the family," "a miniature of [her nephew Louis's] greatgrandfather Louis Lambert Mascillier, and the certificate of his masonic degree," "a silver ladle marked 'L.M.', which belonged to [nephew James's] great-grandfather in 1792," and "a miniature of an infant painted in 1796; also my diamond starbrooch, and a gold chain which belonged to [niece Isabel's] grandmother in and after 1814."65





iv. Gabriel Jean/John Lambert, b. Va., prob. Alexandria, ca. 1805; d. Cherokee Springs, Ga., 9 Sept. 1854. The name of Gabriel's wife (or wives) has not been found, the 1880 census entry for his daughter Matilda says her mother was born in the West Indies, and Gabriel was widowed at the time of his death, perhaps by 1846 when he entered the United States with only his daughters. Gabriel appears on an 1824 passenger list arriving in Maine aboard the *Abiona*, identified as a 19-year-old merchant from Guadeloupe. On 11 May 1846, Augusta Lambert, 4, of the United States [undoubtedly Dalila below], Gabriel Lambert, 42, of the United States, and Matilda Lambert, 12, of Guadeloupe, are listed as the three passengers on the *Caroline* (owned by John Latour of Guadeloupe), at Ponce, Puerto Rico, and bound for Philadelphia. Gabriel's probate in Orleans Parish, La., referred to him as a "widower and left as his sole heirs two children one who is still a minor, named Mathilda Charlotte Lambert wife of A. De Loño of age and Dalila Lambert aged nine years



and both his legitimate children residing in the City of New Orleans."<sup>73</sup>
